### ■ BACKGROUND

With a view to enhancing the standard of the local vehicle maintenance trade, the "Voluntary Registration Scheme for Vehicle Mechanics" has been implemented since 4 January 2007. The registration scheme allows vehicle mechanics in possession of necessary qualifications and/or experience in connection with vehicle maintenance to be registered and gain recognition. With the active support and participation from the vehicle maintenance trade, majority of the vehicle mechanics in the trade have been successfully registered.

### ■ OBJECTIVE OF THE EVENT

The "Trade Skills Competition for Registered Vehicle Mechanics" is to provide the opportunity for registered vehicle mechanics to showcase their skills so as to uplift the professional image of the vehicle maintenance trade, as well as to enhance the public's awareness on the "Voluntary Registration Scheme for Vehicle Mechanics".

### ■ TARGET PARTICIPANTS

All Registered Vehicle Mechanics.

### ■ PARTICIPATION REQUIREMENTS AND PARTICIPATING TEAM

Competition will be on team basis. Participants are free to form their own team which must fulfil all the following requirements:

- Participating team must be formed by five registered vehicle mechanics, with one of them acting as the team leader (each participant can participate in one team only).
- Participating team must have members registered with service classes M, E, B1 and B2. In other words, the participating team must have at least one team member registered with each of the registered service classes. The competition also welcomes the participation of registered vehicle mechanics in the service classes of S. If the participating team can fulfil the requirement of possessing all registered service classes M, E, B1 and B2 by less than five team members, the remaining team member(s) may be registered vehicle mechanic(s) in the service classes of S. This combination can help achieve a better and more balanced skills composition for the team.

## ■ NAME OF PARTICIPATING TEAM

Each participating team shall provide a team name with not more than eight Chinese characters in the entry form. The Organizers reserve the rights to co-ordinate and modify the team name and the concerned participating team must accept.

## ■ COMPETITION ARRANGEMENTS AND CONTENTS

*First Round:* In case of overwhelming entries, each eligible participating team must send one representative to attend a written test. Based on the result of the test, five teams will be selected to enter into the final round.

*Final Round:* The final competition will be in the form of practical assignments which may include the following vehicle maintenance tasks:

- Engine component fault diagnosis and rectification
- Brake system fault diagnosis and rectification
- Tyre fault diagnosis and rectification
- Electrical system fault diagnosis and rectification
- Ignition system fault diagnosis and rectification
- Lighting circuit fault diagnosis and rectification
- Pre-spraying surface preparation and masking
- Body panel alignment

## ■ ASSESSMENT

A Judging Panel will be formed to make assessments for the competition. The assessments will be based on objective criteria, including professional knowledge, competence, safety performance, cooperation, etc. of participating teams.

## ■ AWARDS

Awards of the competition will include:

- Champion, 1st Runners-up and 2nd Runners-up
- Best Cooperative Team
- Others (To be announced)
