表格 WR2 說明

1. 本表格 (表格 WR2) 是註冊電業工程人員根據〔電力 (線路) 規例〕(第 406 章, 附屬法例) 第 20 條的規定, 完成對某一固定電力裝置的定期檢查及測試後, 用以證明該裝置符合法例規定。〔電力 (線路) 規例〕的摘錄載於背頁。本表格可於機電工程署總部客戶服務部或各區政務處諮詢服務中心免費索取, 亦可於機電工程署網頁 <http://www.emsd.gov.hk> 下載。如呈交表格 WR2 的影印本, 將不獲受理。
2. 本表格第 1 及 3 部的所有適用部分, 必須填寫妥當及簽署。第 1 部第 1 項必須由負責檢查及測試工作的註冊電業工程人員, 在檢查及測試日期起計 4 星期內填寫及簽署。
3. 大型的固定電力裝置如果由多於一個部分組成, 則個別部分可由不同的註冊電業工程人員, 使用表格 WR2(A) 來發出證明書。在此情況下, 所有表格 WR2(A) 應全部交給一名主要的註冊電業工程人員, 由他負責為整個固定電力裝置簽發一份「定期測試證明書」(表格 WR2)。如該名主要的註冊電業工程人員認為所收到的各份表格 WR2(A), 已由適當級別的註冊電業工程人員填妥及簽署, 則無須就這些表格 WR2(A) 所填報電力裝置的每個不同部分, 親自進行檢查。
4. 註冊電業承辦商, 或以下第 5 段適用的情況下的擁有人, 在他人為其完成檢查及測試工作後, 必須填妥第 1 部第 2 項和加簽。根據〔電力 (線路) 規例〕(第 406 章, 附屬法例) 第 22(1) 條的規定, 註冊電業承辦商必須為過去 5 年, 或自他註冊為電業承辦商的日期起計, 其僱員進行的電力工程備置及保存一切有關紀錄。
5. 固定電力裝置的擁有人可以全職及固定工資或薪金形式, 僱用適當級別的註冊電業工程人員為該裝置進行電力工程。
6. 本表格的第 1 及 3 部填妥後, 固定電力裝置的擁有人或其代表須於註冊電業工程人員簽發證明書的日期起計 2 星期內, 將表格連同適當數額的加簽費, 遞交機電工程署署長在第 2 部加簽。加簽費不會退還。繳款詳情請參閱「繳款辦法」單張。
7. 機電工程署署長在加簽後, 會將表格 WR2 寄回固定電力裝置擁有人。根據〔電力 (線路) 規例〕(第 406 章, 附屬法例) 第 22(2) 條的規定, 擁有人須將最近期的已加簽證明書 (表格 WR2) 備妥, 以便在機電工程署署長要求時呈交給他查閱。

Notes to Form WR2

1. This form (Form WR2) is used for certification of a fixed electrical installation after it is periodically inspected and tested by a registered electrical worker (REW) under Reg. 20 of the Electricity (Wiring) Regulations (Cap. 406 sub. leg.). An extract from the Electricity (Wiring) Regulations is shown overleaf. Copies of this form may be obtained free of charge from the Customer Services Office, EMSD, Public Enquiry Services Centre of all District Offices and EMSD's web site at <http://www.emsd.gov.hk>. Submission of photocopy of Form WR2 will not be accepted.
2. All appropriate items in Parts 1 and 3 of this form must be properly completed and signed. Item 1 of Part 1 must be completed and signed by a REW, who is responsible for the inspection and testing work within 4 weeks after the completion of the work.
3. For a large fixed electrical installation, which is divided into more than one part, the individual parts may be certified by different REWs of appropriate grades using Form WR2(A)s. In this case, all Form WR2(A)s must then be submitted to a main REW who is responsible for producing a Form WR2 for the whole fixed electrical installation. If the main REW is satisfied that the Form WR2(A)s he received are completed and signed by REWs of appropriate grades, he is not required to personally inspect and test the individual parts of the electrical installation that are covered by the Form WR2(A)s.
4. The registered electrical contractor (REC), or the owner in a case where note 5 below applies, for whom the inspection and testing work is done must complete and endorse Item 2 of Part 1. Under Reg. 22(1) of the Electricity (Wiring) Regulations (Cap. 406 sub. leg.), the REC must make and keep all relevant records of the electrical work carried out by his/her employees for the lesser of 5 years or the time since his registration as an electrical contractor.
5. An owner of a fixed electrical installation may employ a REW of the appropriate grade on a full time basis at a regular wage or salary to do electrical work on that installation.
6. After completion of Parts 1 and 3 of this form, the owner of the fixed electrical installation or his/her representative must deliver the form, together with an endorsement fee of appropriate amount, to the Director of Electrical and Mechanical Services (DEMS) for endorsement in Part 2 within 2 weeks after the date of certification by the REW. The endorsement fee is not refundable. For details of the payment procedure, please see the "Payment Instructions" sheet.
7. After endorsement by DEMS, the Form WR2 will be returned to the owner of the fixed electrical installation by post. The owner must make available, for inspection as and when required by DEMS, the latest endorsed Form WR2 in accordance with Reg. 22(2) of the Electricity (Wiring) Regulations (Cap. 406 sub. leg.).
8. Application may be submitted electronically. For details, please refer to the Government Forms web site at <http://www.info.gov.hk/forms>.

20. Periodic inspection, testing and certification

(1) An owner of a fixed electrical installation located in one of the following type of premises shall have it inspected, tested and certified at least once every 12 months—

- (a) a place of public entertainment as defined in the Places of Public Entertainment Ordinance (Cap. 172) other than a sea-going vessel;
- (b) premises for the manufacturing or storing of dangerous goods listed in the Schedule to the Dangerous Goods (Classification) Regulations (Cap. 295 sub. leg.); and
- (c) premises with a high voltage fixed electrical installation fed directly from a high voltage supply.

(2) An owner of a low voltage fixed electrical installation that has an approved loading exceeding 200A, single or three phase, at nominal low voltage, that is in a factory or industrial undertaking, as those terms are defined in section 2 of the Factories and Industrial Undertakings Ordinance (Cap. 59), shall, unless the factory or industrial undertaking is a premises referred to in subregulation (1), have the installation inspected, tested and certified at least once every 5 years.

(3) An owner of a low voltage fixed electrical installation that has an approved loading exceeding 100A, single or three phase, at nominal low voltage, that is in premises other than those referred to in subregulation (1) or (2), shall have the installation inspected, tested and certified at least once every 5 years.

(4) An owner of a low voltage fixed electrical installation located in one of the following type of premises shall have it inspected, tested and certified at least once every 5 years—

- (a) a hotel as defined in section 2 of the Hotel Proprietors Ordinance (Cap. 158);
- (b) a hospital or maternity home, as those terms are defined in section 2 of the Hospitals, Nursing Homes and Maternity Homes Registration Ordinance (Cap. 165);
- (c) a school as defined in section 3 of the Education Ordinance (Cap. 279);
- (d) premises of the institutions listed in section 2 of the Education Ordinance (Cap. 279);
- (e) a child care centre that is registered under the Child Care Centres Ordinance (Cap. 243); and
- (f) premises that the Director may, by notice posted to or served on the owner, specify that he considers could cause great harm in the event of an electrical accident.

(5) The owner shall deliver a certificate prepared under this regulation to the Director for endorsement within 2 weeks after the date of the certificate.

(6) The owner shall submit an endorsement fee of appropriate amount for each certificate delivered to the Director under subregulation (5). (*L.N. 451 of 1993; L.N. 602 of 1994*)

20. 定期檢查、測試及發出證明書

(1) 設於以下任何一類房產內的固定電力裝置的擁有人，須安排該裝置每 12 個月最少作一次檢查、測試及領取證明書——

- (a) 《公眾娛樂場所條例》(第 172 章) 所界定的公眾娛樂場所，但出海船隻除外；
- (b) 《危險品(類別)規例》(第 295 章，附屬法例) 附表所列的製造或貯存危險品的房產；及
- (c) 由高壓電源直接供電的高壓固定電力裝置所在的房產。

(2) 凡低壓固定電力裝置設於《工廠及工業經營條例》(第 59 章) 第 2 條所界定的工廠或工業經營場地之內，而當額定電壓為低壓時，該裝置的允許負載量為超逾 200 安培(單相或三相)，則除非該工廠或工業經營場地是第 (1) 款所指的房產，否則該裝置的擁有人須安排該裝置每 5 年最少作一次檢查、測試及領取證明書。

(3) 凡低壓固定電力裝置設於不是第 (1) 或 (2) 款所指房產的房產，而當額定電壓為低壓時，該裝置的允許負載量為超逾 100 安培(單相或三相)，則該裝置的擁有人須安排該裝置每 5 年最少作一次檢查、測試及領取證明書。

(4) 設於以下任何一類房產內的低壓固定電力裝置的擁有人，須安排該裝置每 5 年最少作一次檢查、測試及領取證明書——

- (a) 《酒店東主條例》(第 158 章) 第 2 條所界定的酒店；
- (b) 《醫院、療養院及留產院註冊條例》(第 165 章) 第 2 條所界定的醫院或留產院；
- (c) 《教育條例》(第 279 章) 第 3 條所界定的學校；
- (d) 《教育條例》(第 279 章) 第 2 條所列院校的房產；
- (e) 根據《幼兒中心條例》(第 243 章) 註冊的幼兒中心；及
- (f) 署長認為在發生電力意外時會引致嚴重災害的房產，署長可將通知書郵寄或遣專人送達該房產的擁有人，以指明該房產。

(5) 擁有人須將根據本條備妥的證明書，於該證明書的日期起計 2 星期內呈交署長加簽。

(6) 擁有人根據第(5)款將證明書呈交署長時，須繳交適當數額的加簽費。 (*1993 年第 451 號法律公告；1994 年第 602 號法律公告*)

表格 WR2 繳款辦法

1. 每張定期測試證明書（表格 **WR2**）的加簽費為HK\$ **695** 元。此款額可隨時予以調整，而且不會退還。
2. 固定電力裝置的擁有人或其代表應以下列其中一個方法遞交表格 **WR2** 及繳交加簽費：
 - (a) 將表格 **WR2** 連同繳款**寄交**機電工程署署長（地址：香港九龍啓成街3 號機電工程署）
注意：切勿郵寄現金
 - (b) **親臨**香港九龍啓成街3 號機電工程署地下機電工程署客戶服務部
辦公時間： 星期一至五 上午 9 時至下午 5 時 15 分
星期六、日及公眾假期 休息
 - (c) 祇在星期六由上午8時30分至下午12時30分止，將申請表格投入設於本署地下大堂的投遞箱內。
 - (d) 經本署網頁（www.emsd.gov.hk）遞交電子表格。
3. 所有支票、匯票及本票都必須寫明支付「香港特別行政區政府」並加以劃線，切勿寫明支付某一職員。期票不會獲接納。

Payment Instructions to Form WR2

1. The endorsement fee for each periodic test certificate (**Form WR2**) is HK\$ **695**. The fee is subject to revision and is not refundable.
2. Submission of the Form **WR2** and payment of endorsement fee should be made by the owner of the fixed electrical installations or his representative through one of the following methods:
 - (a) **BY POST** addressed to the Director of Electrical and Mechanical Services, Electrical and Mechanical Services Department, 3 Kai Shing Street, Kowloon, Hong Kong. The Form **WR2** must accompany with payment.
N.B.: CASH SHOULD NOT BE SENT THROUGH THE POST
 - (b) **IN PERSON** at the Customer Services Office of the Electrical and Mechanical Services Department, G/F, 3 Kai Shing Street, Kowloon, Hong Kong.
