GUIDANCE NOTES TO COMPLETE FORM 1

Applicants should read this "Guidance Notes to Complete Form 1" together with the leaflet "How to Apply - Builder's Lift and Tower Working Platform Examiner" and the Builders' Lifts and Tower Working Platforms (Safety) Ordinance (the Ordinance) carefully before completing the application form (Form 1). Incomplete application forms or using inappropriate forms may lead to delay in processing or rejection of the application. This application form (Form 1) should only be used for NEW applications for inclusion in the Register of Examiners.

HOW TO COMPLETE THE APPLICATION FORM

Every section in Form 1 should be completed in **block capitals in black**. The applicant should confirm at the beginning of the application form whether the application is made under section 3(2) or section 3(3) of the Ordinance before proceeding to section A. The applicant is advised that the provision of personal data in relation to this application is voluntary. If the applicant does not provide sufficient information, the application may not be able to be processed. A "Personal Data Privacy Statement" in respect of the application is annexed for information.

Section A : Particulars of Applicant

The applicant should provide his / her title, name, HKID / passport number, correspondence address, telephone number, fax number and email address.

Section B : Qualifications

1. If the application is made under section 3(2) of the Ordinance, the applicant should give his / her registered professional engineer number, discipline and expiry date of the certificate of registration in section B(1). A copy of the certificate of registration of R.P.E. should be submitted to this department for record upon the annual renewal of registration.
2. If the application is made under section 3(3) of the Ordinance, the applicant should give his / her academic qualifications including the names and addresses of the institutions, dates of award of the academic qualifications, course titles and classes of awards in section B(2).

Section C : Working Experience

The applicant should provide details of relevant working experience of his / her present and previous employers. The names of the employers, periods of services, posts and nature of work, in particular lift work, should be included. For applications under section 3(3), the applicant should have at least 6 years of relevant experience, of which at least one year should be in connection with installation, testing and examination of builders' lifts and tower working platforms.

Section D : Examples of Lift Work

No matter whether the application is made under section 3(2) or section 3(3) of the Ordinance, the applicant should give at least ten examples of installation, testing and examination of builders' lifts and tower working platforms carried out by himself / herself or under his / her direct supervision. Of these examples, at least one example should be in connection with installation of a builder's lift or tower working platform under a registered contractor. These examples should indicate that the applicant's uninterrupted participation in installation, testing and examination of builders' lifts and tower working platforms for a

period of at least one year. Each example should provide the date of lift work carried out, name of the employer employing or the examiner supervising the applicant, details of lift work, location and identity (make, model and serial number) of the builder's lift / tower working platform.

Section E : Submission of Documents

One copy each of the documents in support of the application should be submitted together with the application form. The applicant should tick the appropriate boxes in this section and attach the corresponding documents in the application form. They may be originals, photocopies with the originals for inspection upon request or certified true copies which should be signed and stamped by a legal practitioner or the issuing organisations. The applicant is recommended to produce his / her identity document for checking by the staff of this department either in the applicant's office or our office instead of submitting the photocopy of the identity document.

Section F : Declaration

The application form should be signed and dated by the applicant in this section.

Purpose of Collection
