Circular No. 11/2007 Code of Practice on the Design and Construction of Lifts and Escalators (2000 Edition) Amendment No. 13 – No Smoking Sign Inside Lift Car

It has come to our notice that section 5 of the Smoking (Public Health) Ordinance (Cap. 371) and paragraph 2 of the Smoking (Public Health) (Notices) Order (Cap. 371 sub. leg. B) had been repealed by the Smoking (Public Health) (Amendment) Ordinance 2006.

It means that it is no longer a statutory requirement to display no smoking signs in the no smoking areas (such as a public lift) under the Smoking (Public Health) Ordinance (Cap. 371).

As such, the Code of Practice on the Design and Construction of Lifts and Escalators (2000 Edition) (the Design Code) has been amended, pursuant to section 27G of the Lifts and Escalators (Safety) Ordinance (Cap. 327), by deleting the requirement on displaying no smoking sign inside the lift car.

The above change has been provided for in Amendment No. 13 of the Design Code which shall become effective with immediate effect. A copy of Amendment No. 13 of the Design Code is attached herewith for your reference.

Furthermore, Circular No. 11/92 issued on 28 May 1992 is hereby cancelled.
