Circular No. 4/2009 Surveillance Audit of Registered Lift/Escalator Contractors

In order to enhance lift and escalator safety, this department will carry out surveillance audit of the registered lift/escalator contractors starting from May 2009.

The purpose of the surveillance audit is to assess the performance of the registered lift /escalator contractors in respect of lifts/escalators maintenance, in particular, whether the registered lift/escalator contractor has the necessary expertise, adequate manpower and resources for provision of maintenance services for the lifts/escalators which they took over from another contractor.

The surveillance audit will be in the form of company visit for documentary records checking, supplemented by site inspections. The areas for assessment shall include but not be limited to the items listed in appendix A.

After the surveillance audit, an audit report will be produced to advise the registered lift/escalator contractor concerned the areas for improvement. Where necessary and appropriate, a copy of the audit report will be sent to the related lift/escalator owners for information.
