1. 註冊資格類別

2. 註冊續期的要求

所有已註冊的升降機工程師或自動梯工程師在申請註冊續期時,需要符合以下要求:

- (甲) 在提交註冊申請日期前之 5 年內,累積不少於 12 個月有關升降機工程及/或自動梯工程的工作經驗;以及
- (乙) 在提交註冊申請日期前之 5 年內,參與不少於 90 小時的持續專業進修課程。(請在申請表的戊部份 第(iii)項提供所參與的培訓課程的詳細內容。)
- 3. **升降機工程或自動梯工程**包括任何升降機或自動梯、或任何其他關乎升降機或自動梯的機械或設備的安裝、試運行、巡視、檢驗及測試、保養、維修、更改或拆卸的各類工作,但建築工程除外。

4. 更改個人資料

如註冊升降機工程師或註冊自動梯工程師的**姓名、通訊地址或身份證明文件**有所更改,該註冊升降機工程師或註冊自動梯工程師須於該更改後的 <u>14 天內</u>,以書面通知機電工程署並提供相關證明。任何人違反上述要求而沒有充分理據,即屬違法,可處罰款\$2,000。如有更改姓名或身份證明文件,註冊升降機工程師或註冊自動梯工程師需遞交其註冊證給機電工程署署長作出更改。

NOTES TO FORM LE36

1. Type of qualifications for registration

An individual is eligible for application for registration as a lift engineer or an escalator engineer if he/she has the qualifications and experience specified in any one of the following routes (i.e. Route 1 and Route 2):

- Route 1 The applicant is a registered professional engineer (R.P.E.) in mechanical engineering, marine and naval architecture engineering, electrical engineering, electronics engineering, building services engineering, or control, automation and instrumentation engineering; and has not less than 2 years' relevant working experience in lift works or escalator works (see also Remark *).
- Route 2 The applicant has a bachelor degree in mechanical engineering, marine and naval architecture engineering, electrical engineering, electronic engineering, building services engineering, or such equivalent or higher qualifications as the Registrar may approve; and has not less than 4 years' relevant working experience in lift works or escalator works (see also Remark *).

Remark

* Practical experience in lift works will be required for registration as a lift engineer, whereas practical experience in escalator works will be required for registration as an escalator engineer. The aggregate periods for lift works and escalator works may overlap if the applicant was engaged in both types of works over the same period of time.

NOTES TO FORM LE36

2. Requirements for renewal of registration as escalator engineers or lift engineers

Every registered lift engineer or registered escalator engineer applying for renewal of registration as a lift engineer or an escalator engineer is required to have:

- (i) been engaged in carrying out lift works or escalator works for an aggregate period of not less than 1 year within the last 5 years before the date of submission of the application for renewal of registration; and
- (ii) attended not less than 90 hours of continuing professional development training courses in the last 5 years before the date of submission of the application for renewal of registration. (Details of the attended training courses should be provided in Section E Item (iii) of the application form.)
- 3. Lift works or escalator works include any kind of works, not being building works, connected with the installation, commissioning, inspection, examination and testing, maintenance, repair, alteration or demolition of an escalator or a lift or of any machinery or equipment connected with an escalator or a lift.

4. Change of Personal Particulars

If there is a change in the name, correspondence address or identity document, the registered lift engineer or registered escalator engineer must, within 14 days of the change, notify the Director of Electrical and Mechanical Services in writing with the proof of change. Any person who without reasonable excuse contravenes such requirements commits an offence and is liable to a fine of \$2,000. For cases of change of name or change of identity document, the registered lift engineer or registered escalator engineer must also deliver to the Director of Electrical and Mechanical Services his/her registration card for amendment.

2. 申請詳情

- (ii) The Applicant can also submit the application and the prescribed application fee to the Registration and Permit Office at G/F, Electrical and Mechanical Services Department Headquarters, 3 Kai Shing Street, Kowloon Bay, in person during the following office hours:

Applications for renewal of registration should normally be made within the period at least 1 month before and no earlier than 4 months before the expiry date of the current registration. Please note requirements under s79(2) of the Ordinance that the submission of the application for renewal should be within the period specified by the Registrar. The registration as a lift engineer and/or an escalator engineer is normally valid for 5 years.

2. Application Details

Applicants are required to submit the duly completed Form LE36, one recent colour passport photograph (35 mm x 50 mm in size) and the prescribed application fee, together with the following copies of documents in support of the application to the Electrical and Mechanical Services Department:

(a) Application for Registration

- (i) Hong Kong Identity Card/passport; (Copy of the identity card/passport is not required if the applicant produces his/her original identity card/passport to our Registration and Permit Office at the time of his/her submission of the application form.)
- (ii) Certificates or testimonials of professional qualifications;
- (iii) Certificates or testimonials of relevant education and academic qualifications;
- (iv) Result of the written examination for candidates applying for registration as lift engineers and/or escalator engineers; and
- (v) Documentary proof of relevant working experience.

(b) Application for Renewal of Registration

- (i) Certificates or testimonials of Continuing Professional Development training courses; and
- (ii) Documentary proof of relevant working experience.

PERSONAL DATA PRIVACY STATEMENT

Purpose of Collection of Personal Data

- 1. The personal data provided by you will be used by the Electrical and Mechanical Services Department ("the Department") for the purposes of:
 - (a) processing your application for registration or renewal of registration as a lift engineer and/or an
 escalator engineer, including approaching the related professional or academic institutions or your
 employer(s) for verification of your professional, academic and training attainment, and experience in
 escalator works and/or lift works;
 - (b) maintaining the register of lift engineers and/or register of escalator engineers established by virtue of Section 105 of the Lifts and Escalators Ordinance, Chapter 618;
 - (c) administering the Lifts and Escalators Ordinance, Chapter 618, and related Regulations; and
 - (d) facilitating communication between the Department and yourself.
- 2. The provision of your personal data is voluntary. If you do not provide sufficient information, the Department may not be able to process your application.

Classes of Transferees

- 3. Upon the acceptance of your application, your personal data will be kept at the Department and may be disclosed or transferred to parties relevant and necessary for the purposes as stated in paragraph 1.
- 4.
