### Notes to Complete this Form 填寫本表格的須知事項

1. This form is the “specified form” under section 18(1)(b) of the Buildings Energy Efficiency Ordinance (Chapter 610).

本表格是建築物能源效益條例（第610章）第 18(1)(b) 條下的「指明表格」。

2. If a composite building is other than “composite (commercial & industrial)” and “composite (commercial & residential)”, please first check whether it meets the definition of “community building” or “municipal building” in Schedule 1 of the Ordinance. If not, please select “other composite use” and specify those usages, such as commercial & hotel.

Pursuant to item 1 of Schedule 3 of the Ordinance, when retrofitting works involve addition or replacement of a building services installation specified in the Building Energy Code and cover one or more places with a floor area or total floor area of not less than 500 m<sup>2</sup> under the same series of works within 12 months in a unit or a common area of a prescribed building, the works will be regarded as “major retrofitting works”. (Please refer to Notes (1) of Schedule 3 of the Ordinance for the interpretation of “a common area”.) However, if retrofitting works involve addition or replacement of a main component of a central building services installation specified in item 2 of Schedule 3 of the Ordinance, the works will be regarded as “major retrofitting works” irrespective of the floor area covered by the works. It is required to complete this form only when retrofitting works are regarded as “major retrofitting works”.

根據《條例》附表3第1項，當裝修工程涉及增設或更換《建築物能源效益守則》所指明的屋宇裝備裝置，而該項工程在於12個月內在訂明建築物的一個單位或一個公用地方進行的同一系列工程下，涵蓋樓面面積不少於500平方米的一個地方，或涵蓋總樓面面積不少於500平方米的多於一個地方，則該項工程會視為「主要裝修工程」。（有關「一個公用地方」的詮釋，請參閱《條例》附表3附註(1)。）不過，若裝修工程涉及增設或更換《條例》附表3第2項所指明的中央屋宇裝備裝置的主要組件，則不論工程所涵蓋的樓面面積多少，該項工程都會視為「主要裝修工程」。只有當裝修工程視為「主要裝修工程」，才須填寫本表格。

6. Pursuant to section 18(5) of the Ordinance, a registered energy assessor who issues a Form of Compliance must—
  - (a) send a copy of it together with the document specified in the Form of Compliance to the Director; and
  - (b) send another copy of it to —
    - (i) the property management company of the building concerned; or
    - (ii) if there is no such property management company or the property management company cannot be found or ascertained, the owner of the building.

Pursuant to section 18(6) of the Ordinance, a registered energy assessor who fails to comply with section 18(5) of the Ordinance commits an offence and is liable on conviction to a fine at level 3 (currently \$10,000).

If no property management company can be ascertained at the time of issuing Form of Compliance, a confirmation of no property management company then by the responsible person indicated in the associated Form of Compliance should be obtained. If the responsible person is also the building owner, issuing Form of Compliance to the responsible person will be regarded as having simultaneously fulfilled the requirement of

section 18(5)(b)(ii) of the Ordinance stated above. The registered energy assessor do not need to send another copy of the Form of Compliance to the owner of building again in this situation.

若發出遵行規定表格之時未能確定有關的物業管理公司，則需要取得關聯的遵行規定表格所示的負責人確認當時沒有物業管理公司。若有關負責人也是建築物擁有人，則發出遵行規定表格於有關負責人會視為已同時履行了上述《條例》第18(5)(b)(ii)條的規定，註冊能源效益評核人在此情況下毋須再將該表格的另一文本送交該建築物的擁有人。

7. This Form of Compliance should be certified and signed by one registered energy assessor only.
