Buildings Energy Efficiency Ordinance (Cap 610) Technical Circular No.1/2022 Launch of Technical Guidelines and Technical Forms for BEC 2021 and EAC 2021

Purpose

This Technical Circular covers the launch of the "Technical Guidelines on Code of Practice for Energy Efficiency of Building Services Installation, 2021 Edition", TG-BEC 2021 in short, and the "Technical Guidelines on Code of Practice for Building Energy Audit, 2021 Edition", TG-EAC 2021 in short, which serves to assist Registered Energy Assessors (REAs) in understanding the technical requirements of the BEC 2021 and the EAC 2021 against the legislative background of the Buildings Energy Efficiency Ordinance (Cap 610) (BEEO).

- 2. The Technical Circular also promulgates the issuance of technical forms namely Form EE-LG 2021, Form EE-EL 2021, Form EE-AC 2021, Form EE-LE 2021 & Form EE-PB 2021 for BEC 2021, Form EE-EA(V.3) & Form EE-EAes 2021 for EAC 2021 and the new revision of "Checklist for COCR Stage 2 / FOC Submission, EE-CH(V.3)" for the use on submission following the BEC 2021 and the EAC 2021.
- 3. The TG-BEC 2021, TG-EAC 2021, Technical forms and checklist, have been uploaded to the web-site of the BEEO (http://www.beeo.emsd.gov.hk).

- 4. The issuance of Technical Guidelines of TG-BEC 2021 and TG-EAC 2021 takes immediate effect to assist the REAs to have a better understand on the BEC 2021 and the EAC 2021.
- 5. The aforesaid technical forms and checklist take effect in accordance with the effective dates of BEC 2021 and EAC 2021 as stipulated under Technical Circular No. 1/2021 Launch of the BEC 2021 and the EAC 2021 issued on 31 December 2021.
