Personal Data Privacy Statement

Purpose of Personal Data Collection

- 1. The personal data you provided by means of this form will be used by the Registration Unit for Technicians Handling Mildly Flammable Refrigerant of Household Air-conditioners of the Electrical and Mechanical Services Department (the Department) for the following purposes:
 - (i) processing and vetting of your application for registration of a technician handling mildly flammable refrigerant of household air-conditioners; and
 - (ii) facilitating communication between the Department and yourself.
- 2. The provision of personal data is voluntary. However, if you do not provide sufficient information, the Department may not be able to process your application.

Classes of Transferees

3. The personal data you provided by means of this form may be disclosed to other Government branches and departments for the purposes mentioned in paragraph 1 above. Upon registration, your personal data limited to your name, registration number, registration class and expiry date of registration may be disclosed to the public at the website of the Electrical and Mechanical Services Department, or to individual upon application.

Access to Personal Data

4.
