**Registration Requirements for Class A:**

(a) The applicant must have a minimum of 6 months of experience in installation of window type air-conditioners in the past 4 years.

**Registration Requirements for Class B:**

(a) The applicant must have a minimum of 2 years of experience in installation of single split / multi-split type air-conditioners and / or carrying out work processes involving handling refrigerant of air-conditioners in the past 4 years.

(b) If the applicant has completed a registered contract of apprenticeship under the Apprenticeship Ordinance (Cap.47) in the air-conditioning and refrigeration trade, he / she must have a minimum of 1 year of experience in installation of single split / multi-split type air-conditioners and/or carrying out work processes involving handling refrigerant of air-conditioners in the past 4 years and after completing the apprenticeship.

(c) If the applicant has passed the Refrigeration / Air-conditioning / Ventilation Mechanic (Unitary System) Trade Test (Skilled Workers) of the Construction Industry Council, he / she must have a minimum of 6 months of experience in installation of single split / multi-split type air-conditioners and/or carrying out work processes involving handling refrigerant of air-conditioners in the past 4 years.

## Personal Data Privacy Statement

### Purpose of Personal Data Collection

1. The personal data you provided by means of this form will be used by the Registration Unit for Technicians Handling Mildly Flammable Refrigerant of Household Air-conditioners of the Electrical and Mechanical Services Department (the Department) for the following purposes:
  - (i) processing and vetting your application for registration of a technician handling mildly flammable refrigerant of household air-conditioners; and
  - (ii) facilitating communication between the Department and yourself.
2. The provision of personal data is voluntary. However, if you do not provide sufficient information, the Department may not be able to process your application.

### Classes of Transferees

3. The personal data you provided by means of this form may be disclosed to other Government branches and departments for the purposes mentioned in paragraph 1 above. Upon registration, your personal data limited to your name, registration number, registration class and expiry date of registration may be disclosed to the public at the website of the Electrical and Mechanical Services Department, or to individual upon application.

### Access to Personal Data

4. According to sections 18 and 22, and Principle 6 of Schedule 1 of the Personal Data (Privacy) Ordinance (Cap. 486), you have a right to request access to and correction of the personal data provided in the application. The right of access includes the right to obtain a copy of the personal data provided by you in this application.
