

Registered Electrical Workers and Contractors - Disciplinary Action

In accordance with Section 36 of the Electricity Ordinance, the Director of Electrical and Mechanical Services may take disciplinary action against a registered electrical worker (REW) or a registered electrical contractor (REC) for non-compliance with the provisions of the Ordinance.

During the period from January 2011 to December 2014, disciplinary actions were taken against the following REWs and RECs being found to have contravened the provisions of the Electricity Ordinance:
