All Owners of the Builder's Lift / Tower Working Platform

Dear Sir / Madam,

Circular No. 1/2022
Written Notification of Incidents involving Builders' Lifts and Tower Working Platforms

Pursuant to Section 26(c) of the Builders' Lifts and Tower Working Platforms (Safety) Ordinance (Cap. 470), the ¹Owners of Builders' Lifts and Tower Working Platforms shall *immediately* notify in writing the Director of Electrical and Mechanical Services ("this office") and the Registered Contractor ("RC") employed by them, when

- (i) any accident occurs, whether or not there is personal injury or property damage associated with it; or
- (ii) there is a failure of any of the following –
 - (a) the driving machine brake;
 - (b) the overspeed governor;
 - (c) the safety gear;
 - (d) the overload sensing device;
 - (e) the suspension system including the rack and pinion suspension system or rope suspension system.

As a clearer guideline, owners of Builders' Lifts or Tower Working Platforms should **within 24 hours** after the time the accident or equipment failure as prescribed above has come to their knowledge, notify the Director of Electrical and Mechanical Services and the relevant RC.

¹ According to the interpretation in Section 2 of the Builders' Lifts and Tower Working Platforms (Safety) Ordinance (Cap. 470), "owner" (擁有人) means the owner of a builder's lift or tower working platform or, where it is leased, means the lessee of it, and includes (a) any agent or person in charge of having the control or management of it; and (b) the contractor who is responsible for the construction site at which it is being used.

A sample format of "Notification of Incident involving a Builder's Lift or Tower Working Platform" is attached to facilitate owners to comply with the above statutory requirement. Please note that you also may visit the following EMSD's weblink or QR code to download a soft copy of the specified form for notification.

In addition, to ensure effective communication and response in handling the incident, you are required to notify this office of any incident *immediately by telephone*, and to await instructions before allowing the RC to start the investigation.
