NOTES TO FORM 2A

- 1. In accordance with section 34(8) of the Electricity Ordinance, a registered electrical contractor shall display in a prominent place at his principal place of business the original of his certificate of registration and a copy of his certificate of registration issued by the Director at each of his other places of business.
 - Application for additional copies of certificate of registration for branch offices should be done by:
 - (a) Completing a Form 2 (for Registered Electrical Contractor) or completing a Form 1 (for Electrical Contractor who has not been registered); and
 - (b) Providing details of branch offices by completing one Form 2A for each branch office and attach all Form 2A to the Form 2.
- 2. Please indicate the details of the branch office in the space provided.
