Notes to applicant:

1. 申請人所申請有關牌照類別之每一項實際電力工作經驗詳情須包括以下事項：

Details of all different grades of practical electrical work of applicant with the following information:

- 實際電力工作種類(包括設計, 安裝及維修等)。如申請C級或B級牌照, 有關實際電力工作經驗的工作種類除安裝及維修外, 必須包括設計的元素。

Type of electrical work(including design, installation and maintenance etc.). Design elements in practical electrical work must be included for Grade C and Grade B application.

- 各項工作之時間, 包括開始及結束日期

Period of each electrical work carried out including start and end dates

- 進行電力工作之位置(如地盤/大廈地址、區域等)

Location of carrying out electrical work (e.g. address of site / building, district, etc.)

- 電力裝置種類(如總掣櫃、上升總線、分掣箱及最終線路裝置等)

Type of electrical installation(e.g. main switchboard, rising mains, distribution board and final circuits etc.)

- 電力裝置(必須註明僱主是否有關電力裝置的擁有人)

2. 如申請人於有關期間並非受僱為電業工程人員, 申請人需在備註欄內註明其進行電力工作之百分比。而實際電力工作年期會按申請人在期內進行相關電力工作之百分比按比例計算。

If the applicant is not employed as an electrical worker during the employment period, applicant should state the percentage involvement by the application at the electrical work in remark column. The practical electrical work counted for the application should be calculated on proportional basis based on applicant actual percentage involved for the electrical work in the working period.

If different grades of practical electrical work (e.g. Grade A, B, C, H and R) has been carried out by applicant and these experience periods have been overlapped, applicant should state the actual percentage involved in remark column of different grades of electrical work. The practical electrical work experience counted for the application of different grades should be calculated on proportional basis.

All documentary proof should be issued in company letterhead and signed by an "Authorized person" of the Registered Electrical Contractor (REC) with company chop. Throughout the entire certified work period, the employer should be valid registered electrical contractor.

5. 證明文件必須提供監督申請人進行電力工作的註冊電業工程人員的姓名, 註冊編號及工程級別。監督人(註冊電業工程人員)在有關電力工作時期必須持有該類別電力工作的有效牌照。

All documentary proof should provide the name, registration number and qualification of the registered electrical worker who supervised the applicant to carry out the electrical work. Throughout the entire certified work period, the supervisor should be valid registered electrical contractor of corresponding qualification.
