- For application on replacement of certificate of REW due to change of name, or replacement of certificate of REC due to change of business address or company name, the applicant must return the original existing certificate of REW / REC with the duly completed Form ER41.
- For application for a certified true copy of an endorsed Periodic Test Certificate (WR2), applicant should be the owner of the fixed electrical installation at the premises, management company for the premises or incorporated owners of the premises. Applicant should provide evidence to substantiate their status for our vetting.
