Note 3:

Eugene Engineering Co. Limited (Eugene) was involved in an industrial incident during rope replacement happened on 5 August 2014. The Court fined Eugene for \$6,000 on 3 July 2015 regarding her failure to ensure that adequate safety precautions were taken. The record of non-compliance will be announced in the next quarter.

Note 4:

Fujitec (HK) Co. Ltd. was involved in a lift incident of suspension rope breakage happened on 13 January 2014. A warning letter was served in 1/2014 and the record for such non-compliance was kept for 1 year till 1/2015. At present, the incident case is under criminal proceeding.

Note 5:

Schindler Lifts (Hong Kong) Ltd. was involved in a lift incident of suspension rope breakage happened on 8 May 2014. A warning letter was served in 6/2014 and the record for such non-compliance was kept for 1 year till 6/2015. At present, the incident case is under criminal proceeding.

Note 6:

A lift incident happened on 8 October 2014 in an industrial building in Kwun Tong. The incident was caused by severe overload. During the investigation, the EMSD found that there were inadequacies in the maintenance works

and working procedure of the lift contractor, ThyssenKrupp Elevator (HK) Limited. The EMSD will conduct a disciplinary inquiry into the case.

Note 7a:

Antonfield Engineering Co., Ltd. (Antonfield) pleaded guilty to the charge for failing to notify the Director of Electrical and Mechanical Services for major alteration works on a lift. The Court fined Antonfield for \$5,000 on 4 March 2015 for the contravention of the Lift and Escalator (General) Regulation (Cap.618A). Criminal proceeding of the case was completed in September 2014. The record of non-compliance will be kept for one year until 9/2015.

Note 7b:

Ben Fung Machineries & Engineering Ltd. (Ben Fung) was involved in a lift incident of over-travel during maintenance happened on 26 January 2014. The Court fined Ben Fung for \$ 3,000 on 14 January 2015 regarding her failure of inputting the lift fault information and the event details in the log book. The record of non-compliance will be kept for one year until 1/2016.

Note 7c:

Non-compliance found in safety aspect, thus served with warning letter. The record of non-compliance will be kept for one year until 8/2015.
