Note 2 : Performance Index (Full mark of 100) = Maintenance Index (0 to 50 marks) + Safety Index (0 to 50 marks); Maintenance Index = $50 \times (1 - \text{cumulative maintenance performance monitoring points} / \text{number of inspections in the period})$; Safety Index = $50 - \text{cumulative safety performance monitoring points}$ (each critical safety non-compliant item with 15 Points). The cumulative performance monitoring points are valid for 12 months.
