Note 2 :	Performance Index (Full mark of 100) = Maintenance Index (0 to 50 marks) + Safety Index (0 to 50 marks); Maintenance Index = 50 x (1 - cumulative maintenance performance monitoring points / number of inspections in the period); Safety Index = 50 - cumulative safety performance monitoring points (each critical safety non-compliant item with 15 Points). The cumulative performance monitoring points are valid for 12 months.
