## Circular No. 6/2020 Virtual Reality-based Lift Maintenance Simulator (VRLMS)

The Electrical and Mechanical Services Department (EMSD), the Lift and Escalator Contractors Association and the Vocational Training Council, have been working in collaboration to develop the VRLMS which allows trainees to learn and practise lift maintenance activities in an immersive environment capable of rectification of mistakes through learning and practice. The learning through mistakes by the VRLMS is particularly useful and can effectively heighten trainees' awareness of work safety where mistakes in real life can be extremely detrimental and must be avoided.

The first two phases of the VRLMS development project have been completed and the following safety training modules are now available free to registered lift contractors (RLCs) for their internal training:

- i. Accessing to and egressing from the lift car top,
- ii. Operating the lift car on the lift car top,
- Accessing to and egressing from the lift pit, iii.
- Working in the lift machine room, and iv.
- Carrying out lift maintenance that involves electrical work. ٧.

RLCs who are interested in adopting the above training modules, please write to the General Legislation Division 1 of EMSD and confirm understanding and agreement to the following terms and conditions:

- The recipient of the VRLMS training modules (the Recipient) shall not i. directly or indirectly disclose or make the VRLMS modules available to any third parties or the public, unless agreed by EMSD.
- The Recipient shall only use the VRLMS training modules for in-house ii. training of its employees or its sub-contractors' employees.
- EMSD may request the Recipient to report the usage (include, but not iii. limited to, number of training courses organized, number of employees trained etc.) of the VRLMS training modules.

iv. The Recipient and its employees shall not copy or reproduce the VRLMS training modules. If necessary, the Recipient may request further copies from EMSD.
