**Circular No. 10/2015**  
**Probity Guidelines for Registered Lift Engineers**  
**and Registered Escalator Engineers**

The Independent Commission Against Corruption (ICAC) conducted an Assignment Study on Regulation of Lifts and Escalators in 2014 and recommended, among others, EMSD issue probity guidelines for registered persons under the Lifts and Escalators Ordinance with a view to enhancing the professionalism of the trade.

In consultation with ICAC, registered lift engineers and registered escalator engineers, EMSD has developed the captioned probity guidelines as attached. All registered lift engineers and registered escalator engineers are required to observe and follow these probity guidelines with immediate effect.

# **Probity Guidelines for Registered Lift Engineers and Registered Escalator Engineers**

## **1. Responsibility to the Profession**

The engineer shall order his conduct so as to uphold the dignity, standing and reputation of the Profession. He shall:

1. discharge his professional responsibilities with integrity;
2. give opinions in his professional capacity that are, to the best of his ability, objective, reliable and honest;
3. accept responsibility for his actions and ensure that persons to whom he delegates authority are sufficiently competent to carry out the associated responsibility; and
4. not undertake responsibility which he himself is not qualified and competent to discharge.

## **2. Responsibility to Employers/Clients**

The engineer shall discharge his duties to his employer/client with integrity and in accordance with the highest standards of business ethics. He shall:

1. avoid engaging in business, investments or activities which conflict with the interests of his employer/ client, and inform his employer/client in writing of any possible conflict between his own financial interests (including those of his immediate family) and the interests of his employer/client;
2. where possible advise those concerned of the consequences to be expected if his engineering judgment, in areas of his responsibility, is overruled by his employer/client;
3. neither give nor accept any gift, entertainment, payment or service of more than nominal value, to or from those having a business relationship with his employer/client without the consent of the latter; and
4. safeguard confidential information in relation to his employer/client and not disclose such information to third parties without the written consent of his employer/client.

## **3. Responsibility to the Public**

The Engineer, in discharging his responsibilities to his employer/client and the profession, shall at all times be governed by the overriding interest of the general public, in particular their safety. In carrying out lift/escalator examination as well as other lift/escalator works, he shall always put public safety as the top priority.
