NOTES TO FORM LE46

- 1. For registered lift or escalator engineer and registered lift or escalator worker, the applicant must be the holder of the certificate or card. For registered contractor, the applicant must be the respective authorized signatory of the company.
- 2. This application form (Form LE46) is only applicable to the certificate holder or card holder who has a certificate of registration or a registration card lost, destroyed, defaced or damaged.
- 3. A duplicate certificate or duplicate card issued has the same effect as, and is equivalent to the original certificate or original card.
- 4. On the issue of a duplicate certificate or duplicate card, the original certificate or original card ceases to be valid.
- 5. When making an application for a duplicate certificate or duplicate card, the certificate holder or card holder must return the original certificate or original card to the Registrar if it is available to the certificate holder or card holder.
- 6. The Registrar may refuse to issue a duplicate certificate or duplicate card to the certificate holder or card holder if the holder contravenes Item 5 above.

ii) Applicant can also submit the application form, copies of relevant documents, and application fee in the form of a cheque to our Customer Services Office at G/F, Electrical and Mechanical Services Department Headquarters, 3 Kai Shing Street, Kowloon Bay, by post.

PERSONAL DATA PRIVACY STATEMENT

Purpose of Collection of Personal Data

- 1. The personal data provided by you will be used by the Electrical and Mechanical Services Department ("the Department") for the purposes of:
- (a) processing your application for issue of duplicates of registration certificates and registration cards;
- (b) maintaining the register of contractors, the register of engineers and/or the register of workers established by virtue of section 105 of the Lifts and Escalators Ordinance, Chapter 618;
- (c) administering the Lifts and Escalators Ordinance, Chapter 618, and related Regulations; and
- (d) facilitating communication between the Department and yourself.
- 2. The provision of your personal data is voluntary. If you do not provide sufficient information, the Department may not be able to process your application.

Classes of Transferees

- 3. Upon the acceptance of your application, your personal data will be kept at the Department and may be disclosed or transferred to parties relevant and necessary for the purposes as stated in paragraph 1.
- 4. Your personal data limited to your name, registration number, class of registration, date of registration, expiry date of registration, and name of employer(s) may be disclosed to the public at the Government website "http://www.emsd.gov.hk" and the Customer Service Office of the Electrical and Mechanical Services Department.

Access to Personal Data

5. You have a right to request access to and make correction of your personal data as provided for in sections 18 and 22 and Principle 6 of Schedule 1 of the Personal Data (Privacy) Ordinance. Your right of access includes the right to obtain a copy of your personal data provided by you in the application. A fee may be imposed for obtaining a copy of such data.
