- 2. Applicant is required to submit the duly completed Form ER 42 to our Registration and Permit Office, Ground Floor, the Electrical and Mechanical Services Department Headquarters, 3 Kai Shing Street, Kowloon Bay either in person during the following office hours or by post:

Monday to Friday 9:00 a.m.to 5:15 p.m

Saturday, Sunday and Public Holidays closed

Applicant can also submit application through any one of the following methods:

- (a) By post to the Director of Electrical and Mechanical Services at the above address;
- (b) By putting applications into the drop-in box located at G/F lobby of Electrical and Mechanical Services Department on Saturday only from 8:30 a.m. to 12:30 p.m.

Applicant is required to bring along the original documents for verification.

3. Registered Electrical Contractor should use ER 41 to notify EMSD of the change of business address. The required fee has been stated in the Notes and payment instruction to FORM ER 41.
