# **Information to Kiddie Ride Owners**

### 有關小童機動遊戲機之法例

機動遊戲機(安全)條例(第 449 章)及 機動遊戲機(安全)(操作及保養)規例(第 449 章**B**)旨在:

- 加強公眾人士在使用機動遊戲機及小童機動遊戲機時的安全
- 就機動遊戲機及小童機動遊戲機之安裝、操作及保養事宜訂立規管

## 什麼是小童機動遊戲機?

一般為投幣式及較簡單之機動遊戲機。而較技術性的釋義為:


額定功率承功率	不超過 1.1 千瓦
承載重量	不超過 100 千克
使用者	12 歲以下小童

## 須經機電工程署署長批准的事項

- 操作小童機動遊戲機供公眾人士使用(表格4或表格31)
- 對小童機動遊戲機作重大改裝(表格 10)
- 經重大改裝後,恢復使用及操作(表格 12)

## 小童機動遊戲機擁有人的責任

- 提供及展示載列違禁行為、載客量及准許承載重量的告示
- 每天檢查及保養維修小童機動遊戲機
- 凝備檢查紀錄冊以供機電工程署檢查
- 如有需要,安排適當員工操作有關小童機動遊戲機
- 向機電工程署報告任何受傷或與小童機動遊戲機有關的事故
- 每六個月安排檢測員或合資格人員\*檢驗小童機動遊戲機一次
- 保存檢驗報告以供機電工程署查閱

#### **Legislation Related to Kiddie Rides**

Amusement Rides (Safety) Ordinance (Cap. 449) and Amusement Rides (Safety) (Operation and Maintenance) Regulation (Cap. 449B) aim to:

- Enhance public safety in use of amusement rides and kiddie rides
- Provide regulation control over the installation, operation and maintenance of the amusement rides and kiddle rides

#### What is a Kiddie Ride?

Basically, they are usually coin-operated and rather amusement rides with simply design. Technically speaking, they should follow the specifications below:

Power Rating	Not more than 1.1 kW
Carrying Capacity	Not more than 100 kg
User	Children under 12

#### Approval Required from the Director of Electrical and Mechanical Services

- Operation of the kiddie rides for the use of members of the public (Form 4 or Form 31)
- Major alteration of kiddie rides (Form 10)
- Operation after major alteration (Form 12)

#### **Duties of Kiddie Ride Owners**

- Provide and display notices specifying prohibited conduct, number of passengers and weight permitted in each ride
- Inspect, maintain and repair the kiddie ride daily
- Keep a log book for inspection by EMSD
- Arrange appropriate staff to operate the kiddie ride if necessary
- Report to EMSD any incident involving injury and issue related to the kiddle ride
- Arrange a surveyor or qualified person\* to examine the kiddie ride once every six months
- Keep the examination report for inspection by EMSD
- \* All surveyors and qualified persons must be approved by EMSD. The list of registered surveyors and qualified persons who agree to disclose their personal information, can be downloaded from the following website,
