Personal Data Privacy Statement

Purpose of Personal Data Collection

- 1. The personal data provided by means of this form will be used by the Vehicle Maintenance Registration Unit of the Electrical and Mechanical Services Department ("the Department") for the following purposes:
 - (i) processing of your application as a registered vehicle mechanic; and
 - (ii) to facilitate communication between the Department and yourself.
- 2. The provision of personal data is voluntary. If you do not provide sufficient information, the Department may not be able to process your application.

Classes of Transferees

3. The personal data you provided by means of this form may be disclosed to other Government branches and departments for the purposes mentioned in paragraph 1 above. Upon registration, your personal data limited to your name, registration number, registered service class and expiry date of registration may be disclosed to the public at the website of the Electrical and Mechanical Services Department, or to individual upon application.

Access to Personal Data

4. You have a right to request access to and make correction of the personal data as provided for in sections 18 and 22 and Principle 6 of Schedule 1 of the Personal Data (Privacy) Ordinance. The right of access includes the right to obtain a copy of your personal data provided by you in the application.
