1. The Applicant of this Form means the responsible person for the lift/escalator who employs or arranges the registered lift/escalator engineer to issue a certificate or the responsible person's representative. If the Cessation Order is issued to a registered lift/escalator contractor, the Applicant is the registered lift/escalator contractor.
2. The Applicant must complete and sign this Form. This Department will contact the Applicant or mail letters through the correspondence address provided by the Applicant. If there is any change to the correspondence address, the Applicant should notify this Department in writing and clearly state the lift/escalator location ID for updating the contact details. If it is required according to the conditions in note 3 below, the Applicant must ensure that the appointed registered lift/escalator engineer or registered lift/escalator contractor completes and signs the certificate in Annex 1 or Annex 2 of this Form (Form LE18).
3. The condition for considering cancellation of Prohibition Order/Cessation Order, as shown in the table below, should be complied with:

Ground(s) for Issuing Prohibition Order	Condition for considering cancellation of Prohibition Order
Form LE 16 (a)	A registered lift/escalator engineer has certified that the safety measures implemented can effectively prevent the lift from carrying any person or being overloaded.
Form LE 16 (b)	In respect of a newly installed lift/escalator or one to which major alteration has been carried out, a valid Use Permit or Resumption Permit has been issued by the Director. In the case of a lift/escalator to which any works that are likely to affect the safe operation of the lift/escalator has been carried out, it has been certified by a registered lift/escalator engineer that the lift/escalator is in safe working order.
Form LE 16 (c)	A registered lift/escalator contractor has agreed to undertake the periodic maintenance works in respect of the lift/escalator.
Form LE 16 (d)	The lift/escalator concerned has been issued a valid Use Permit.
Form LE 16 (e)	A registered lift/escalator engineer has certified that the remedial measures implemented can effectively eliminate the risk of injury to any person or damage to any property that may arise from the use or operation of the lift/escalator.
Form LE 16 (f)	A registered lift/escalator engineer has certified that the lift/escalator is in safe working order.
Form LE 16 (g)	A registered lift/escalator engineer has certified that the safety hazard associated with the lift/escalator has been eliminated.

Ground(s) for Issuing Cessation Order	Condition for considering cancellation of Cessation Order
Form LE 17 (a)	A registered lift/escalator contractor has undertaken to deploy qualified person(s) to carry out or supervise the lift/escalator works.
Form LE 17 (b)	A registered lift/escalator contractor has undertaken to take adequate remedial measures to eliminate the risk of injury to any person or damage to any property in respect of the carrying out of the lift/escalator works.
Form LE 17 (c)	A registered lift/escalator contractor has undertaken to implement measures in respect of the lift/escalator works so far as to ensure that safety problem no longer exists while the works are being carried out.
