3. 註冊續期的要求

所有已註冊的升降機工程人員或自動梯工程人員在申請註冊續期時，需要符合以下要求：

- (甲) 在提交註冊申請日期前之 5 年內，已累積最少 1 年的相關工作經驗；以及
- (乙) 在提交註冊申請日期前之 5 年內，已完成最少 30 小時的相關訓練。(請在申請表的已部份第(ii)項提供所參與的訓練課程的詳細內容。)

4. **升降機工程或自動梯工程**包括任何關於升降機或自動梯或其相聯設備或機械的安裝、試運行、檢驗、保養、修理、更改或拆卸的各類工作。

5. **更改個人資料**

如註冊升降機工程人員或註冊自動梯工程人員的**姓名、通訊地址或身份證明文件**有所更改，該註冊升降機工程人員或註冊自動梯工程人員應於該更改後的 **14 天內**，以書面通知機電署並提供相關證明。

1. Classifications of registration

- a) **Class A** registered lift worker or **Class A** registered escalator worker who is employed by the registered lift/escalator contractor who undertakes the works are authorized to personally carry out:
- (i) lift works or escalator works in respect of the lift or escalator before the first use permit for a lift or an escalator is issued, excluding any examination; and
 - (ii) demolition of a lift or an escalator.
- b) **Class B** registered lift worker or **Class B** registered escalator worker who is employed by the registered lift/escalator contractor who undertakes the works are authorized to personally carry out:
- (i) lift works or escalator works in respect of the lift or escalator after the first use permit for a lift or an escalator is issued, excluding any examination or demolition of the lift or the escalator.
- c) **Class C** registered lift worker or **Class C** registered escalator worker who is employed by the registered lift/escalator contractor who undertakes the works are authorized to personally carry out:
- (i) examination of a lift or an escalator.

2. Type of qualifications for registration

An individual is eligible for application for registration as a lift worker or an escalator worker of the respective classification if he/she has the qualifications and experience specified in any one of the following types (i.e. **TYPE 1 to TYPE 8**) :

- a) An individual is eligible for application for registration as a lift worker or an escalator worker or both with the classification (**Class A + B + C**) if he/she:
- TYPE 1**
 - (i) has been an apprentice in the trade of lift or escalator electrician or lift or escalator mechanic or a similar trade recognized by the Registrar; and
 - (ii) has at least 4 years' relevant working experience, in that at least an aggregate period of not less than 1 year of the experience was obtained within the 5 years immediately before the date of submission of application for registration.
 - TYPE 2**
 - (i) has completed a certificate course in building services engineering, electrical engineering, electronic engineering, marine engineering or mechanical engineering, recognized by the Registrar; or any other course recognized by the Registrar to be equivalent to or of a higher level than the aforementioned certificate course; and
 - (ii) has received relevant training; and
 - (iii) has at least 4 years' relevant working experience, in that at least an aggregate period of not less than 1 year of the experience was obtained within the 5 years immediately before the date of submission of application for registration.
 - TYPE 3**
 - (i) has passed a trade test for lift works or escalator works recognized by the Registrar; and
 - (ii) has received relevant training; and
 - (iii) has at least 8 years' relevant working experience, in that at least an aggregate period of not less than 1 year of the experience was obtained within the 5 years immediately before the date of submission of application for registration.
 - TYPE 4***
 - (i) is considered by a registered lift contractor or registered escalator contractor to have obtained sufficient experience and training in lift/escalator works (including installation, demolition, maintenance and examination) ; and
 - (ii) has received relevant training; and
 - (iii) has at least 4 years' relevant working experience, in that at least an aggregate period of not less than 1 year of the experience was obtained within the 5 years immediately before the date of submission of application for registration.
- b) An individual is qualified for registration as a **Class A** lift worker or a **Class A** escalator worker if he/she :
- TYPE 5***
 - (i) is considered by a registered lift contractor or registered escalator contractor to have obtained sufficient experience and training in lift/escalator installation or demolition works;

- and
- (ii) has received relevant training; and
- (iii) has at least 4 years' relevant working experience, in that at least an aggregate period of not less than 1 year of the experience was obtained within the 5 years immediately before the date of submission of application for registration.

- TYPE 6***
- (i) has been in the employment by a lift or escalator sub-contractor and is considered by a registered lift contractor or registered escalator contractor to have obtained sufficient experience and training in lift/escalator installation or demolition works; and
 - (ii) has received relevant training; and
 - (iii) has at least 4 years' relevant working experience, in that at least an aggregate period of not less than 1 year of the experience was obtained within the 5 years immediately before the date of submission of application for registration.

c) An individual is qualified for registration as a **Class B** lift worker or a **Class B** escalator worker if he/she :

- TYPE 7***
- (i) is considered by a registered lift contractor or registered escalator contractor to have obtained sufficient experience and training in lift/escalator maintenance works; and
 - (ii) has received relevant training; and
 - (iii) has at least 4 years' relevant working experience, in that at least an aggregate period of not less than 1 year of the experience was obtained within the 5 years immediately before the date of submission of application for registration.

d) An individual is qualified for registration as a **Class C** lift worker or a **Class C** escalator worker if he/she :

- TYPE 8***
- (i) is considered by a registered lift contractor or registered escalator contractor to have obtained sufficient experience and training in lift/escalator examination works; and
 - (ii) has received relevant training; and
 - has at least 4 years' relevant working experience, in that at least an aggregate period of not less than 1 year of the experience was obtained within the 5 years immediately before the date of submission of application for registration.

3. Requirements for renewal of registration as lift workers or escalator workers

Every registered lift worker or registered escalator worker applying for renewal of registration as a lift worker or an escalator worker is required to have:

- a) been at least one year's relevant working experience obtained within the 5-year period immediately before the date of submission of the application; and
- b) completed at least 30 hours of relevant training within the 5-year period immediately before the date of submission of the application. (Details of the training courses should be provided in Section F Item (ii) of the application form.)

4. **Lift works or escalator works** includes any kind of works concerning the installation, commissioning, examination, maintenance, repair, alteration or demolition or any associated equipment or machinery of a lift or an escalator.

5. Change of Personal Particulars

If there is a change in the name, correspondence address or identity document, the registered lift worker or registered escalator worker should, within 14 days of the change, notify the Director of Electrical and Mechanical Services in writing with the proof of change.

- * TYPE 4 to TYPE 8 are transitional arrangements.
