# 申請須知

# (1) Submission of Application

#### 遞交申請的方法

This application form shall be submitted with the information as prescribed in Section C of the form, by hand, fax, designated electronic application submission system (including email) or post, to 'The Gas Authority, Gas Standards Office, Electrical & Mechanical Services Department, 3 Kai Shing Street, Kowloon, Hong Kong'.

本申請表格必須連同表格丙部所訂明的資料,以傳真或經指定電子提交申請系統(包括電郵)遞交,或親身送交或郵 寄至「香港九龍啟成街 3 號機電工程署氣體標準事務處氣體安全監督」。

#### (2) Application Processing Time

The Gas Authority shall notify the applicant in writing within 40 working days from the date of receipt of the application of whether the application is approved or the applicant is required to provide additional information.

# (3) Application Fee

The fee for new application for registration of a gas supply company is HK\$18,940 (application fee is not required for change of gas business or change of company particulars). The fee for replacement of certificate of registration is HK\$150. Fees shall be in the form of cheque, draft or cashier's order and made payable to 'The Government of HKSAR' and crossed.
